- 2. Application of willing candidate, fulfilling the above conditions and eligibility as per the attached Recruitment Rules may be forwarded through proper channel only along with: -

  - (iii) Vigilance Clearance Certificate
  - (iv) A statement given details of major/minor penalties imposed on the officer, if any, during the last 10 years.
- 3. The period of deputation shall be five years. The lending organisation may relieve an officer for a lesser period, as per its policy/rules/regulations, subject to a minimum of three years.
- 4. The Maximum age limit for appointment by deputation shall be not exceeding fifty-six years as on the last date of receipt of applications.
- 5. The officials selected will be posted at Office of Commissioner of Railway Safety, Central Circle, Mumbai.

In addition to entitled LTC, one set of complimentary railways pass and one set of privilege ticket order of appropriate class will be given to the employee so appointed in the Commission of Railway Safety during the period of deputation. However, for Railway employees, the normal pass rules will apply.
- 8. Terms & Conditions:-
  - (i) The applicant must fulfill the essential qualification and experience for the post as mentioned above as well as other conditions stipulated in this advertisement.
  - (ii) The applicant is advised to satisfy himself/herself before applying that he/she possess at least the essential qualification/experience as laid down in the respective Recruitment Rule for the post.
  - (iii) Only applications received through proper channel and with the approval of Cadre Controlling Authority shall be considered for appointment.
  - (iv) The maximum age limit for appointment by deputation shall not be exceeding 56 years as on the closing date of receipt of application.
